### Lead Program Rules/Clarifications

Application date on qualifying applications must be between January 1 and June 30, 2015. Qualifying applications are based on all new, issued policies that are underwritten

or are submitted via Open Enrollment. Internal replacements do not count toward qualification. Qualifiers must maintain an 80% persistency on qualifying business. The cost of the lead program credit will be reported to you as taxable income on IRS Form 1099.

Transamerica has the exclusive right to change the program rules during the qualification period as is subject to all state compensation restrictions based on the issue state of the policy. Participation is based on meeting the qualifications listed above, and the qualifier must be in compliance with all company and state marketing laws

& regulations and be in good standing with Transamerica and its legal entities at the time the lead program credit is given. Agents must be properly appointed and approved to sell the Stonebridge and Transamerica Premier Life Medicare Supplement product in the specific states listed in order to submit business.
